### **Quarantine measures for travellers arriving from overseas during the pandemic of COVID-19**

Due to the current COVID-19 situation in Sri Lanka and globally, following quarantine measures are imposed for travellers arriving in Sri Lanka.

Letters No. DGHS/COVID-19/347/2021 dated 28.09.2021, 03.10.2021 and 17.10.2021 on Quarantine measures for travellers arriving from overseas during the pandemic of COVID-19 are hereby cancelled.

#### **A Entering into the country**

Foreign Nationals who do not have a valid visa, have to obtain a landing permit / visa from the Department of Immigration & Emigration prior to their departure.

	Valid resident visa holders are allowed to undergo home quarantine if facilities are available at home.

**B Approval to Quarantine at a Residence for Foreign national staff members of the diplomatic missions or UN organizations / UN Specialized agencies / International Organizations with permanent offices in Sri Lanka (mentioned in Annex 01) who are holding Diplomatic / UN / Official passports**

<b>B.1</b>	Foreign National Staff members and their <b>accompanying</b> spouse, parents and children are allowed to undergo mandatory Quarantine at a Quarantine Hotel / Safe & Secure Certified Level 1 Hotel / Quarantine at an area Medical Officer of Health (MOH) approved residence.
<b>B.2</b>	If Foreign National staff members of Diplomatic Missions or Foreign National staff members of organizations/agencies are undergoing mandatory quarantine at a residence, respective Diplomatic Mission / Organization / Agency with permanent offices in Sri Lanka should take prior approval in writing from area MOH mentioning that the residence is suitable for mandatory quarantine.
<b>B.3</b>	Details of the Foreign National Staff members and their accompanying spouse, parents and children undergoing mandatory quarantine at approved residences should be informed to area MOH on Day 1 of arrival, as they have to quarantine under the supervision of area MOH.

**C Pre departure negative COVID-19 PCR test report**

<b>C.1</b>	Travellers of <b>two years and above</b> arriving in Sri Lanka should mandatorily carry a negative <b>COVID-19 PCR test report</b> in English language done <b>within 72 hours prior to embarkation</b>
<b>C.2</b>	<b>Travellers</b> with a history of COVID-19 infection <b>during past six months</b> and only with a single dose of vaccine taken after two weeks of recovery and their unvaccinated children below 18 years could arrive with a <b>negative COVID-19 PCR Report done within 72 hours of embarkation</b> . If they have a <b>history of infection within last three months, instead of a PCR test, they could arrive with a negative COVID-19 Rapid Antigen Test report</b> done within 48 hours prior to embarkation. They should carry a diagnosis card or verifiable evidence or positive PCR report or positive Rapid Antigen Test report as a proof of past history of illness (in English).

**D COVID-19 Vaccination Certificate/Card**

<b>D.1</b>	Travellers who have received the recommended doses of COVID-19 vaccine should carry the original vaccination certificate / card (together with a certified copy of English language translation if the certificate/card is not in English or if relevant data are not indicated in English in a non - English certificate / card) or verifiable evidence of vaccination.

**E "Fully Vaccinated" travellers**

<b>E.1</b>	If the <b>recommended doses of the COVID-19 vaccination are completed</b> and <b>departs from abroad two weeks after completion of vaccination</b> , they will be considered as " <b>Fully Vaccinated</b> ".
<b>E.2</b>	As there are positive cases reported among fully vaccinated persons in Sri Lanka and in other countries, it is important to minimize the spread of COVID-19 or its variants entering in to the country. Therefore, all travellers including fully vaccinated travellers should not relax the preventive measures and should abide by the COVID-19 preventive measures imposed by the Government of Sri Lanka.



## F Procedures to follow at the arriving airport in Sri Lanka

F.1	Each traveller should submit a completed <b>Health Declaration Form</b> to the staff of the Airport Health Office at the health counters of arriving airport. Separate Health Declaration Form should be submitted for each of accompanying children if any.
F.2	Travellers who have completed the recommended doses of the COVID-19 vaccination and departs from abroad <b>after two weeks of completion of vaccination</b> , should produce the vaccination certificate / card / verifiable evidence (in English) to Airport Health Officer at arriving airport.
F.3	After completion of formalities at the airport, travellers who are required to be quarantined will be transferred to a Quarantine Centre / Quarantine Hotel managed by the Government of Sri Lanka or to a Safe & Secure Certified Level 1 Hotel. Transport shall be provided by the government authorities or the Hotel Management on a pre-determined manner. Respective Diplomatic Mission / Organization / Agency with permanent offices in Sri Lanka should arrange their own transport (adhering to preventive measures imposed by Government of Sri Lanka) to transport Foreign National staff members, if undergoing quarantine at an area Medical Officer of Health (MOH) approved residence.

## G. Procedures to be followed after released from the arriving airport

All other Seafarer / Sea marshal operations including quarantine measures for Seafarers / Sea marshals **arriving via seaports** should be done adhering to the provisions in Standard Operating Procedures issued by the Ministry of Health.

## I Travellers with Positive COVID-19 test reports

I.2	<ul style="list-style-type: none"> <li>• All Ministry of Health approved laboratories (Private and State sector) conducting COVID-19 tests, should inform the Positive test results with the details of the positive person immediately to Epidemiology Unit (chepid@slt.net.lk and samithag@hotmail.com) and area MOH.</li> </ul>



I.3	<ul style="list-style-type: none"> <li>• Sri Lankan Citizens (including Sri Lankan Seafarers / Sea marshals), Dual Citizens can be allowed to isolate at home or at an Intermediate Care Centre / designated hospital.</li> <li>• Resident Visa Holders can be allowed to isolate at home or at an Intermediate Care Centre managed by Private Hospital / designated Private Hospital.</li> <li>• Foreign National staff members of the diplomatic missions or UN Organizations / UN Specialized agencies / International Organizations with permanent offices in Sri Lanka, can be allowed to isolate at residence or at an Intermediate Care Centre managed by private hospital/ designated private hospital.</li> <li>• All other Foreign Nationals will be sent to an Intermediate Care center managed by private hospital/ designated private hospital.</li> </ul>

They should be registered at home care management system in Sri Lanka by informing the area MOH.</li> <li>• If released for Home Isolation, they should stay at home / residence without leaving the premises and practice all health measures to prevent other family members at home / residence getting infected.</li> <li>• They have to follow the guidelines issued by Ministry of Health on Home Care Management for positive persons.</li> </ul>

## J Other Measures

J.1	In charge officer of the Quarantine Hotel / Quarantine Centre or Hotel Doctor at Safe & Secure Certified Level 1 Hotel / the staff of Airport Health Office should verify the status of vaccination of the traveller.
J.2	In charge officer of the Quarantine Hotel / Quarantine Centre or Hotel Doctor at Safe & Secure Certified Level 1 Hotel should issue a "Discharge Document" when discharging travellers who are undergoing quarantine.
J.3	If the Day 1 PCR test report is negative, Tourists arriving via Sri Lanka Tourism are allowed to move between Safe & Secure Certified Level 1 Hotels in a bio-secure travel bubble and allowed to visit approved important sites in a bio-secure travel bubble during the quarantine period.
J.4	<p>PCR testing of the travellers after arriving in Sri Lanka should be conducted by a Ministry of Health approved laboratory (Private sector or State sector).</p> <p>List of approved Private Sector Laboratories is available at Ministry of Health Website (<a href="http://www.health.gov.lk/moh_final/english/news_read_more.php?id=999">http://www.health.gov.lk/moh_final/english/news_read_more.php?id=999</a>)</p>
J.5	If a COVID-19 test result of an accompanying traveller of the child is positive, exempted children will also be subjected to PCR testing subsequently.
J.6	Quarantine period of travellers will be extended, if they are identified as immediate close contacts of a COVID-19 positive person or if they arrive from high-risk countries as decided by health authorities.

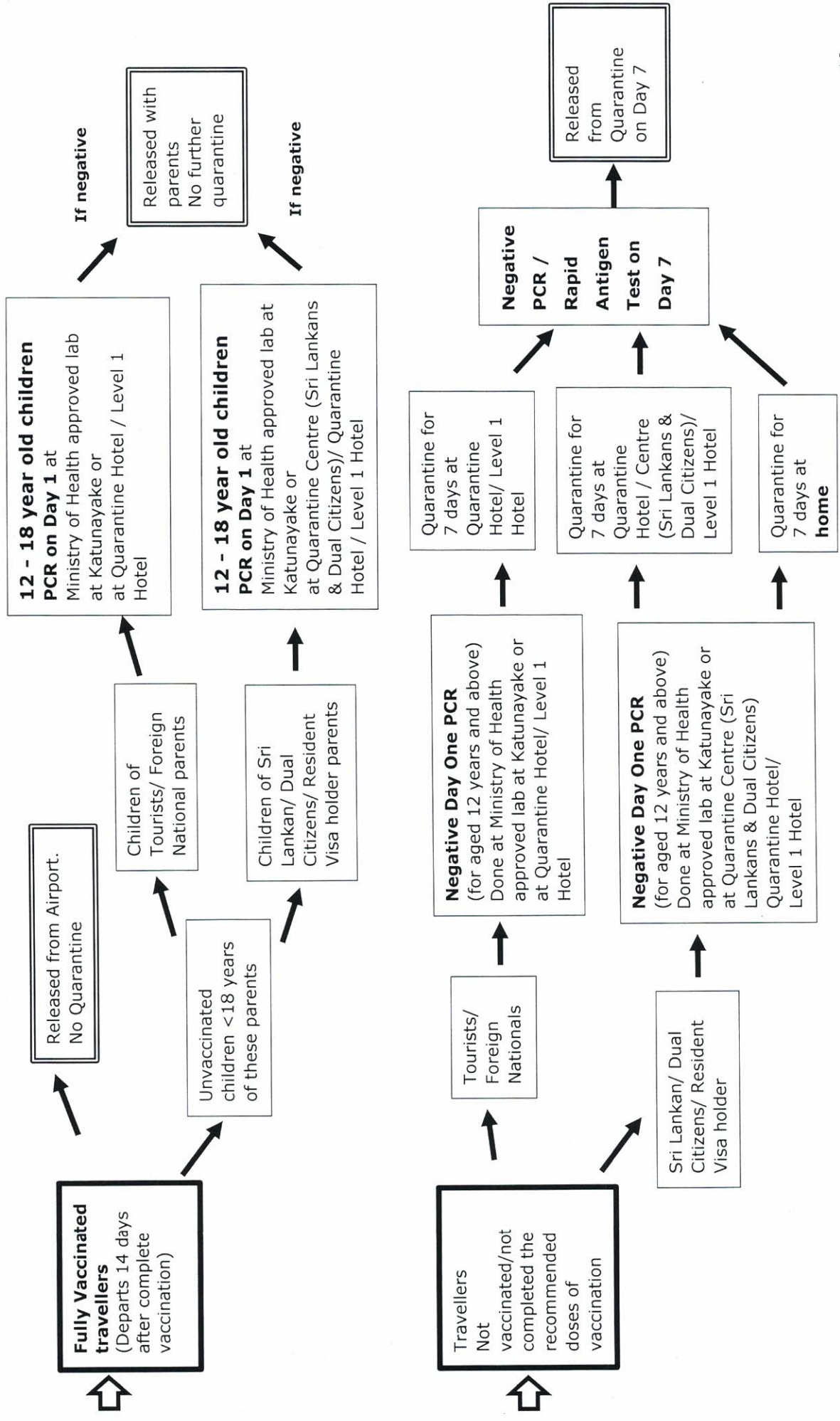

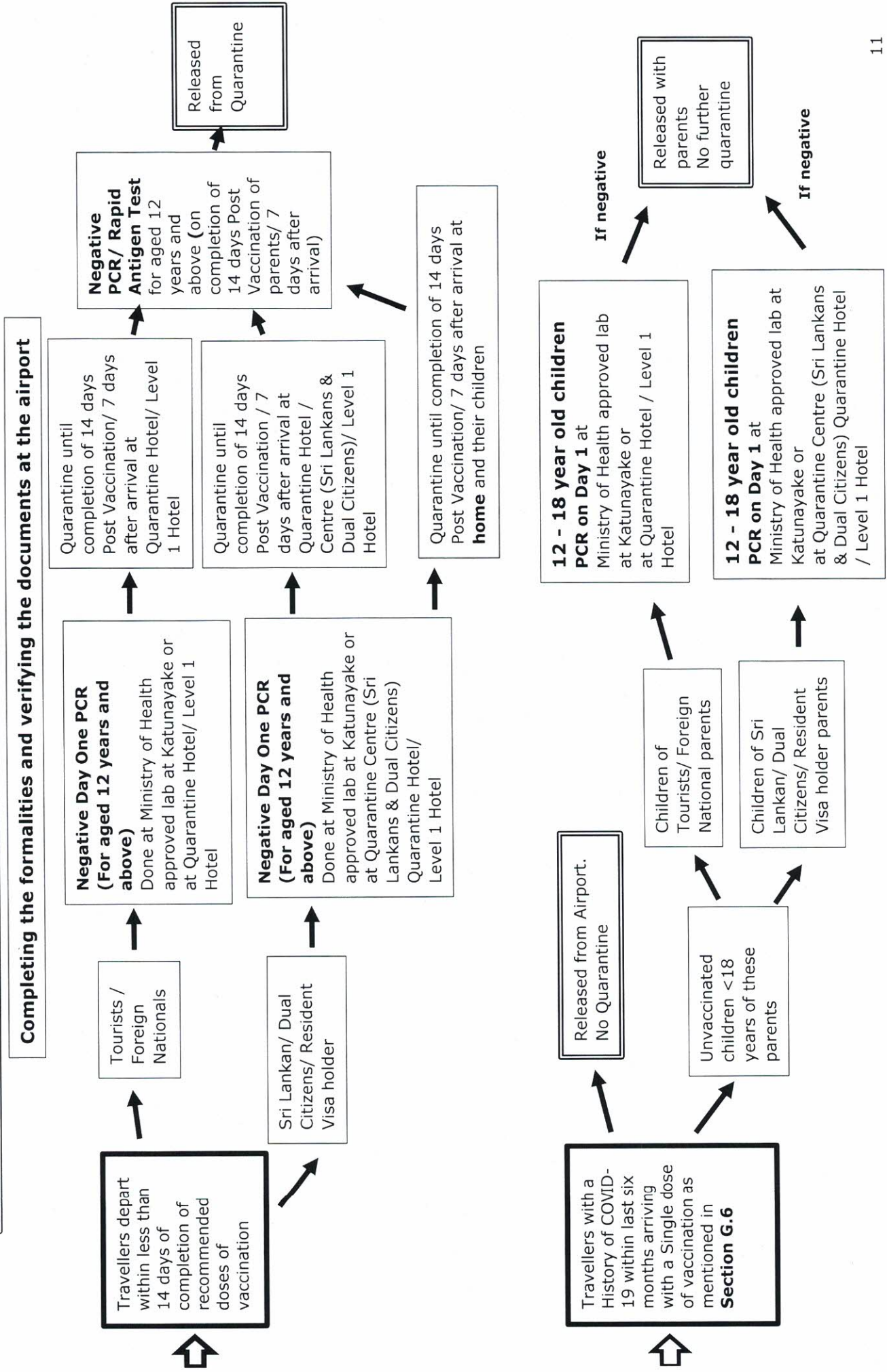
